GENERAL

During my career in law enforcement, I have investigated and or reconstructed over 950 accidents as a field investigator and accident reconstructionist. I have attended about 1500 hours of formal training on traffic collision investigation and related fields. I have spent an additional 250 plus hours on skid testing, acceleration testing and lamp examinations (including microscopic), as part of an on-going training process within the MARR unit. I have surveyed and or measured over 1000 accident/crime scenes. I have been electronically mapping collision and crime scenes since 1993, which includes several hundred vehicle damage profiles. I have testified at oral depositions and arbitrations in King County District Courts as an expert in collision reconstruction dozens of times that are not specifically dated and or mentioned. I have

been consulting privately on civil and criminal cases since April 2006. I have reconstructed and or analyzed an additional 3000 or more cases in my private consulting practice.
